FCA Free carrier (named place)

The seller obligation is fulfilled, when he has delivered the goods, cleared for export, to the carrier nominated by the buyer at the named place. It should be noted that the chosen place of delivery has an impact on the obligation of loading and unloading the goods at that place.

The buyer bears all costs and risks from the time they have been delivered at the named place.

FCA Frei Frachtführer (benannter Ort)

Die Lieferverpflichtung des Verkäufers ist erfüllt, wenn er die zur Ausfuhr abgefeigte Ware dem vom Käufer benannten Frachtführer am benannten Ort liefert. Zu beachten ist, daß der ausgewählte Ort der Lieferung Folgen für die Verpflichtungen zur Be- und Entladung der Ware an diesem Ort nach sich zieht.

Der Käufer übernimmt ab diesem Zeitpunkt alle die Ware betreffenden Kosten und Gefahren.

CIF Cost, Insurance, Freight (named port of destination)

The seller has the same obligations as under CFR-clause.

In addition to that he has to procure marine insurance on minimum coverage and pays the insurance premium.

CIF Kosten, Versicherung, Fracht (benannter Bestimmungshafen)

Gleiche Verpflichtungen des Verkäufers wie bei CFR-Klausel.

Zusätzlich hat der Verkäufer die Verpflichtung, eine Versicherung zu Mindestbedingungen abzuschließen und die Prämie zu bezahlen.
